Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

Applicability. The Form HUD-50075-HCV is to be completed annually by **HCV-Only PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, Small PHA, or Qualified PHA do not need to submit this form. Where applicable, separate Annual PHA Plan forms are available for each of these types of PHAs.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS and SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

B.3	<p>Progress Report.</p> <p>Provide a description of the PHA’s progress in meeting its Mission and Goals described in its 5-Year PHA Plan.</p> <p>PHA Goal: Achieve High Performer SEMAP Rating: The Section 8 Management Assessment Program (SEMAP) enables HUD to identify housing authority capabilities and deficiencies related to the administration of the program. Grading is based on 15 different indicators. We did not obtain a high performer rating because of scoring the maximum number of points on the Leasing Indicator.</p> <p>PHA Goal: Increase Homeownership Participants It is our goal to increase our number of Homeownership families by 2 households this year. The Housing Authority of Americus has developed a subdivision which consists of 19 Lots for the purpose of transitioning low- and moderate-income families into homeownership. The Housing Authority of Americus will build the homes and sell the homes to the families at 60% of the cost to building. The remaining 40% will be financed by the HAA through issuing the family a 10-year Forgivable 2nd Mortgage. We are continuing to seek to attract all interested families that have acceptable credit scores and can obtain financing. With the rise in interest rates, and the inability of participants to achieve favorable credit scores we have experience difficulties transitioning into homeownership.</p> <p>PHA Goal: Expanding the supply of affordable housing. Attracting new landlords to participate in the Housing Authority’s rental assistance programs has continued to be a priority. The landlord engagement program has not proven to be successful, but we plan to have two (2) outreach activities this year to attract new participating landlords. Existing landlords attended an information session regarding the implementation of the NSPIRE Inspection requirement, but we did not attract any new landlord.</p> <p>We have also initiated purchasing homes that are listed on the local market with our Non-Federal Funds as a means of increasing the available properties for HCV Voucher Holders to lease. It is also our goal to initiate the construction phase to build 48 Locally Owned Units and make these units available for HCV Voucher Holders.</p> <p>PHA Goal: Family Self-Sufficiency (FSS) We were recently awarded an FSS Grant for a coordinator; therefore, it is our goal to increase resident participation in the program. It is our goal to increase participation from 5 to 25 participants.</p>

Until such time as the PHA is required to submit an AFH, the PHA will not have to complete section D., nevertheless, the PHA will address its obligation to affirmatively further fair housing in part by fulfilling the requirements at 24 CFR 903.7(o)(3) enacted prior to August 17, 2015, which means that it examines its own programs or proposed programs; identifies any impediments to fair housing choice within those programs; addresses those impediments in a reasonable fashion in view of the resources available; works with local jurisdictions to implement any of the jurisdiction's initiatives to affirmatively further fair housing that require the PHA's involvement; and maintain records reflecting these analyses and actions. Furthermore, under Section 5A(d)(15) of the U.S. Housing Act of 1937, as amended, a PHA must submit a civil rights certification with its Annual PHA Plan, which is described at 24 CFR 903.7(o)(1) except for qualified PHAs who submit the Form HUD-50077-CR as a standalone document.
